

WaterSense Toilet Program

The WaterSense Toilet Program provides a rebate of up to \$75 to homeowners who purchase a high-efficiency toilet (HET). This offer is valid for toilets purchased between January 1 and December 31, 2012. Program funds are limited and rebates are available on a first-come, first-serve basis. Offers ends December 31, 2012, or when program funds are exhausted. Please read and follow the instructions carefully and allow 4 to 6 weeks for your rebate check.

INSTRUCTIONS & REQUIREMENTS

1. The toilet you purchase must have the EPA WaterSense label and use a maximum of 1.28 gallons per flush—no exceptions. Go to www.everettwa.org/conservation for a list of qualifying models.
2. The toilet must be installed in a single family home (house or condominium) or multifamily building (with four or fewer units) that is served by a water district or water association. No private wells.
3. The home must be located in Snohomish County, WA—excluding Hat Island and the following zip codes: 98077, 98241, 98251, 98256 and 98292.
4. The rebate amount is based on the pre-tax price of the toilet or \$75, whichever is less. Rebates cover the cost of the toilet only, not additional parts, labor charges or tax.
5. You can apply for one rebate per home, for a maximum of \$75. If you already applied for a rebate in 2010 or 2011, you no longer qualify
6. You must complete and sign the application form and return it within 60 days of the purchase date to: WaterSense Rebate, 3200 Cedar Street, Everett, WA 98201. Applications submitted beyond 60 days of the purchase date will not be processed.
7. You must attach a copy of the sales receipt to the application. If the receipt does not indicate the brand and model number of the toilet you purchased, you must provide other documentation, such as the WaterSense label and model number from the packaging.
8. Please write legibly and provide all of the information on the form. Incomplete applications or applications lacking the required documentation will not be processed.
9. Please detach the form and do not use staples or tape to attach the receipt to the application.
